
**Project Questionnaire and Submission Checklist**

Instructions and General Requirements: Entities requesting funding from the Capital Project Sales Tax Commission bear the responsibility of providing reliable cost estimates and other critical information concerning their project proposals. An entity's failure to provide this information may cause its project submission to be determined ineligible by the Commission. In order to be considered eligible, all proposals must be accompanied by the required answers to all inquiries made below. (Exemptions from requirements may be approved by vote of the CPST Commission, contingent upon satisfactory justification being shown.) Incomplete responses or omissions of responses may cause projects to be excluded from the 2022 CPST Commission ballot question. In addition to including the information requested below, each project proposal submission must be accompanied by a cover letter from a qualifying entity or entities that will own and/or operate the facility/project once its construction is completed. In addition to the required cover letters, representatives of affected entities must include for each project submission a copy of this instruction form, complete with signatures acknowledging its content.

### 1. Project Description, Sponsoring Entity/Entities, and Official Statement(s) of Ongoing Support

A. Define the project in general terms. Include the scope of services it would provide, the community of users it would serve, and its proposed geographic location.

This Project is the proposed rehabilitation of existing asphalt roads and associated drainage structures located throughout portions of the entire area of Lexington County, totaling approximately 360 miles in length with a total cost of \$109.6 million including engineering, construction and inspection. This project submission is broken into the prioritized packages shown in Section 3 and attached.

The County roads selected for this project were chosen from the Lexington County Pavement Management database that has a pavement condition index less than 60. The Pavement Condition Index (PCI) is a numerical index between 0 and 100, which is used to indicate the general condition of a pavement. All County roads have been visually inspected and scored according to the types and severity of distress observed. This condition index can give a good indication of the pavement condition of a network. The objective of this request would be to address the worst roads, creating a onetime increase in the network PCI. At current budget projections, the PCI of the network will continue to decrease (meaning the roads will progressively get worse). This project would increase the overall PCI of the County paved network to a level above what the current budget and continued use of preventative maintenance techniques would be.

The State roads selected for this project were identified based on their interconnectivity with selected County roads and the negative impacts on the traveling public from the current poor conditions. State roads that are already programmed for improvements are not included in this proposed project.

This Project would address about 98 miles of County maintained roads and about 262 miles of SCDOT maintained roads.

The Project includes all phases of work and costs for a typical asphalt maintenance program including asphalt patching, drainage repair, milling, resurfacing and full depth reclamation and surface placement.

B. Who would own the project upon its completion? [Under the CPST statute, completed projects must be owned by the County, a municipality, a special purpose district (e.g. water and sewer authority), or some combination of qualifying entities; limited exceptions provide for joint ownership of CPST projects by school districts with other public entities.]

All proposed work is to be performed within existing SCDOT or Lexington County right of way. SCDOT will continue to maintain roads in the State system, and Lexington County will continue to maintain roads in the County system.

Yes, per section 4-10-330 (A) (1) (a): *“highways, roads, streets, bridges, and public parking garages and related facilities;”*

This project would not generate revenues directly. However, when considering the life cycle costs of projects and the current condition of the roads selected, there are savings to be had long term. Without this funding, the overall condition of the paved road network will continue to decrease, meaning each road will cost more to fix or not receive the necessary preventive measures that extend the useful life of the asphalt. Improving the worst of the roads with this project would allow the County and State to spend its maintenance dollars on long term preventative measures. Lower cost prevention measures extend the life of the asphalt and preserve the initial cost expenditure.

Additionally, the rehabilitation of existing paved roads helps increase or sustain property values. This will result in increased tax revenue for Lexington County. Improved roadway surfaces reduce travel time for all users, residential and businesses. Many jobs will also be created for this project over the next several years.

### 2. Site Planning for Project Implementation

The proposed asphalt resurfacing would be within the existing rights of way of the roads and will require negligible earth moving activities.

The proposed project is for asphalt resurfacing of existing roadways and will not have any ancillary uses associated with it.

D. If the project is provisionally approved for inclusion on the referendum ballot, is the sponsoring entity/are the sponsoring entities financially able to provide soil and environmental testing needed to assure the property's suitability for the project, if requested to do so by the Commission?

Lexington County understands that the proposed project will be restrained by the budget estimated for the project. To stay within the budget, the scope of the project may be revised.

E. Is the property being recommended for this use currently under the ownership of the proposing or sponsoring public entity/entities? If not, what are the specific plans of the sponsoring entity/entities for obtaining the needed property?

All proposed work is to be performed within existing SCDOT or Lexington County right of way.

F. Do any easements, zoning regulations, covenants, or other restrictions apply that would present obstacles to using this property for the proposed project?

All proposed work is to be performed within existing SCDOT or Lexington County right of way.

This project will impact various types of properties throughout Lexington County. Work will be performed in residential communities as well and commercial and industrial settings. This project will impact residents and non-residents who travel in Lexington County.

### 3. Construction Planning and Budgeting

A. Provide square footage (size) estimates and building-use descriptions of all structures and ancillary uses proposed for location on the project site. Provide a total cost estimate for the construction portion of the project, including building, engineering, architectural, and project management costs.

The projected costs for each repair is based on historical data plus a suitable contingency to address any drainage improvements, curb replacement, or unforeseen expenditure. The project is broken into 8 prioritized packages with cost estimates for each road shown in the attached table.

Package 1 – (1-24) 24 roads totaling about 47 miles - \$14.4 million  
Package 2 – (25-110) 85 roads totaling about 49 miles - \$15.1 million  
Package 3 – (111-151) 41 roads totaling about 45 miles - \$13.9 million  
Package 4 – (152-265) 114 roads totaling about 44 miles - \$13.3 million  
Package 5 – (266-334) 69 roads totaling about 42 miles - \$12.8 million  
Package 6 – (335-461) 127 roads totaling about 44 miles - \$13.5 million  
Package 7 – (462-565) 104 roads totaling about 44 miles - \$13.5 million  
Package 8 – (566-675) 110 roads totaling about 43 miles - \$13.2 million

F. Will the proposed structures include design elements aimed at achieving energy efficiency? If so, please describe these design elements and their anticipated effectiveness.

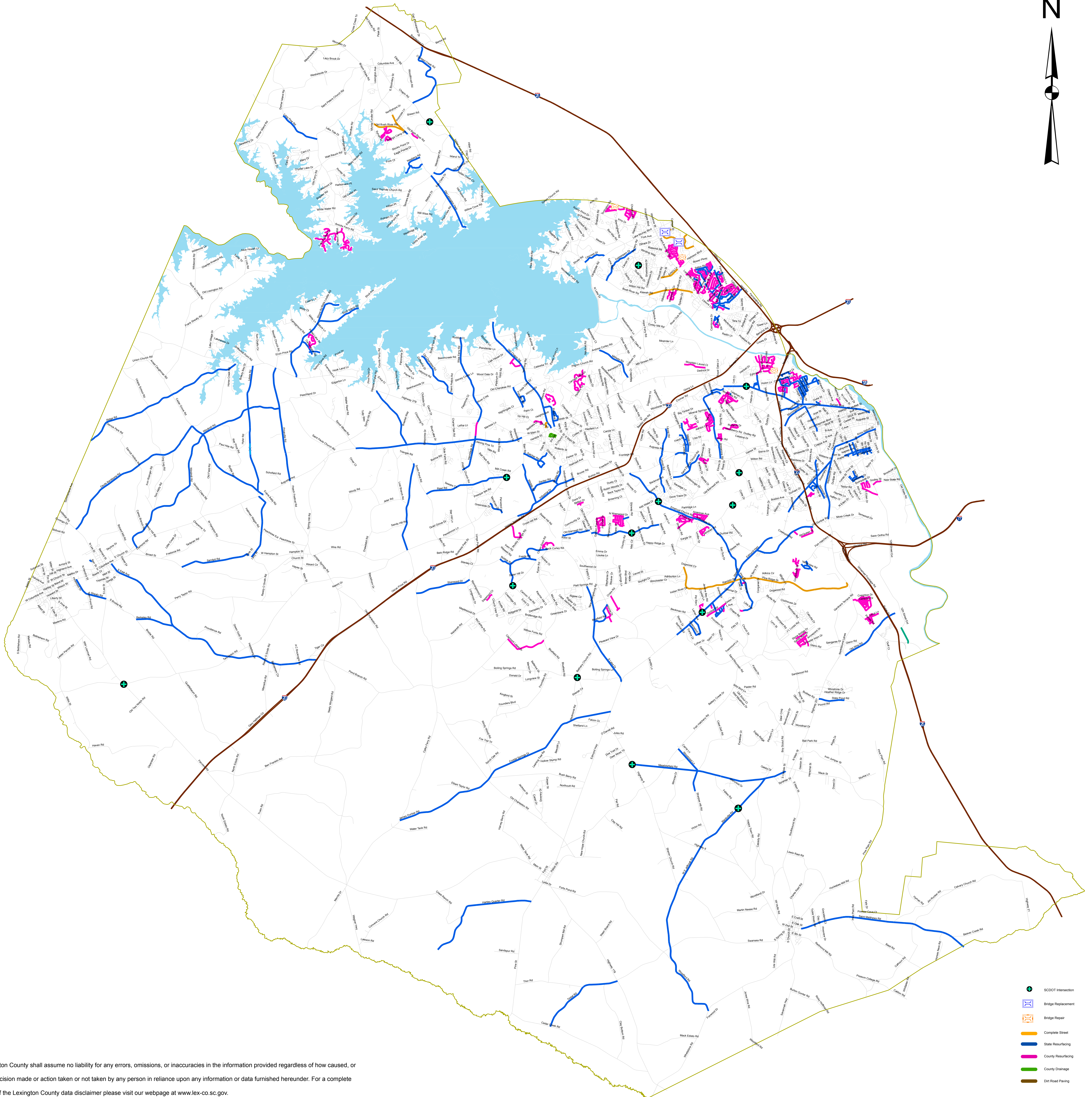
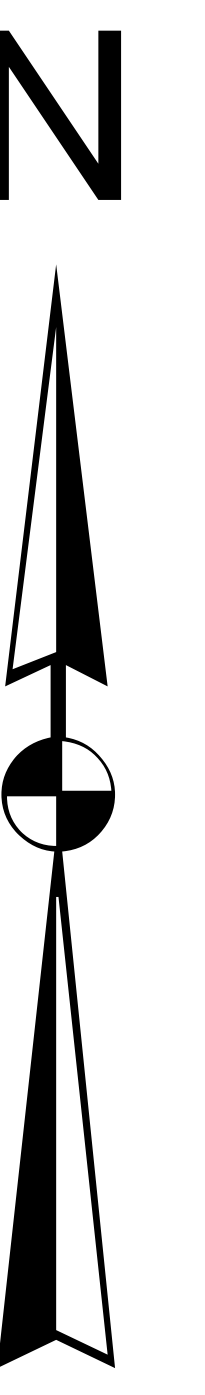
The proposed asphalt resurfacing will not include energy efficiencies not normally found in this type of construction.










Lexington County understands that cost overruns associated with this project will be the responsibility of the County. The scope of the project may be revised to stay within the estimated budget. If funding were available the project design and planning are anticipated to take 3 months from award. Upon the award of work, construction will take an additional 24 months for each package.
